1) INTRODUCTION & BACKGROUND

Contract type: Consultancy and Services

Duration of assignment: 2 Months

3) PURPOSE

Pakistan is among the top water crisis counties in the world and ranked 14 out of 17 among the high water-risk counties, with an average per capita water availability of 964 m³ per annum. in light of such scenarios, WWF-Pakistan has initiated a five-year project called "Scaling up Nature-based Solution for Implementing integrated water resources management and enhanced water security in Pakistan" with the financial support of the Foreign Commonwealth Development Office (FCDO) through the WWF-UK.

The objective of the Consultancy:

This assignment aims to provide sustainable livelihood opportunities to marginalized communities by integrating nature-based solutions (NBS).

Specific tasks for consultant:

- Conduct inception meeting(s) with the WWF team and develop an understanding of the tasks and for the selection of the site;
- Consultation with relevant govt department for the establishment of fish farm;
- Desk review of the relevant literature on the establishment of aquaculture facilities for fish farming that suit the site-based environmental conditions;
- Submit a work plan with clearly defined activities and sub-activities required for the project's completion;
- Conduct a visit to the selected sites for understanding and better layouts;
- Develop layout plans for the establishment of the aquaculture facilities for fish farming;
- Designs with BOQs to be included
- Submit an estimated budget for the establishment of a fish aquaculture facility;
- Supervise the construction work of fish farms along with the WWF staff;
- Advice on the selection of the fish species for farming, keeping in view the local environmental condition;
- Establishing WWF liaison with the fish seed provider(s)/vendor(s);
- Design a manual for the operation of the fish aquaculture facilities, maintenance, and management in Urdu and English languages;
- Conduct a training session for the community and WWF staff on fish farming, including maintenance and management of fish farms;
- Support in the establishment of market linkages;
- Share at least two draft reports before submission of a final comprehensive report
- Submit a comprehensive activity report

Approach & Methodology:

- Before the start of the activity, the consultant will provide a brief implementation strategy roadmap in the form of an inception report.
- The consultant will keep on board all relevant stakeholders to execute the assignment in line with the expected deliverables.
- All logistics, food and accommodation will be bear by WWF-Pakistan

4) DELIVERABLES

- Layouts of the fish aquaculture facilities for the selected sites;
- A report on the selection of suitable fish species for farming in the areas;
- Fish aquaculture manual for management and maintenance;
- Training for the persons engaged in the operation and maintenance of fish farms;
- Market strategy for disposal of the produce;
- Submission of the activity report.

- Fluent in Urdu and English languages. Pashto speaking will be an advantage

8) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

- 2) Experience:
 - a) Description of the complete projects: the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) Provide template of already complete similar type of reports- the WWF-PAKISTAN may request additionally;
- 5) Service Provision Timeline Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

9) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

10) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
 - Detailed workplan
 - Expression of interest (EOI)
 - Company's Profile
 - Detailed methodology
- B) Financial Proposal (30%)
 - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
 - Company's registration certificate
 - NTN detail(s)
 - Any legal or technical certification required for the task
 - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
