1) INTRODUCTION & BACKGROUND

Contract type: Consultancy and Services

Duration of assignment: 2 Month 20 Days starting from 20th Oct to 31st Dec 2023

WWF Pakistan has vast past and current working experience on how integrated water management (IWM) can improve the balance between ecosystem, community, and economic health as well as the needs of the diverse stakeholders on land and water. WWF-Pakistan has been working on a project - to pilot sustainable water management of Lahore in different areas.

3) PURPOSE OF CONSULTANCY

. The purpose of this consultancy is to undertake critical tasks aimed at enhancing the safety and well-being of students and staff in low-fee government and private schools in low-income neighborhoods of Lahore. The pivotal task is conducting a comprehensive water quality assessment in selected schools, meticulously analyzing water samples for potential contaminants, including sewage infiltration, and presenting the findings in a detailed report equipped with infographics and diagrams to vividly illustrate the state of water quality in these institutions. This report should not only delineate the current conditions but also propose viable solutions to mitigate any identified issues, thereby paving the way for healthier learning environments.

In conjunction with this, there will be a focused effort on WASH (Water, Sanitation, and Hygiene) data collection, which will involve gathering detailed information on the existing sanitation facilities and hygiene practices in these schools. This data will be instrumental in identifying areas that require urgent intervention and will aid in formulating strategies to foster improved WASH conditions in the schools.

The ultimate goal is to craft scientifically backed paper that not only shed light on the current predicament but also propose sustainable solutions, grounded in a thorough understanding of the existing infrastructure and the needs of the community. Through this consultancy, we aspire to foster a safer, healthier future for the students and staff in these educational institutions, championing the cause of safe water and hygiene through informed, actionable insights and strategies.

4) DELIVERABLES

The consultant(s) is expected to submit the following deliverables by the end of this consultancy:

- 1. Water Quality Assessment and WASH Data Collection Report
- 2. Conduct a comprehensive physical and microbial water quality assessment in twenty government and private schools in low-income neighborhoods of Lahore, analyzing water samples for potential microbial contaminants, including total coliforms, fecal coliforms, and *E. coli* and presenting the findings in a detailed report with analytical graphs and comparisons.
- 3. Gather detailed WASH (Water, Sanitation, and Hygiene) data from the selected schools, focusing on the existing sanitation facilities and hygiene practices, and compile this data into a comprehensive report that outlines the current state and suggests actionable improvements.
- 4. Prepare at least one scientific manuscript based on the results drawn from the water quality.
- 5. Organize and host a data dissemination seminar at the end of the project to present the findings and insights gathered during the consultancy to the WWF team.
- 6. Incorporate feedback from the project team on the above report (if any).

5) PROJECT/ ASSIGNMENT TIMELINE

The consultant/Firm shall provide a detailed service provision timeline per milestones and phases. The assumed commencement date of the assignment is <u>Oct 20th 2023</u>, and the completion date is <u>Dec 31, 2023</u>

6) REQUIREMENTS

Minimum requirements

- **Education:** The person should have a master's degree, preferably in marine sciences, environmental studies, environmental business management or environmental economics;
- **Experience:** At least 05 years of experience in research studies and developing scientific papers and reports is required. Preference will be given to those who have had relevant experience.
- **Skills/ language:** Effective verbal and non-verbal communication, with expertise in local languages, Urdu and Punjabi, is required.

8) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

 - **a) Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) **Provide template of already complete similar type of reports-** the WWF-PAKISTAN may request additionally;
- 5) Service Provision Timeline Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

9) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

10) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- a) Technical Proposal 70%
- b) Financial Proposal 30%

The following criteria shall be used as a basis for evaluation of technical proposals:

Qualifications (maximum 30 points)

- Experience relevant to the assignment (maximum 30 points)
- Adequacy of the proposed methodology and work plan (maximum 20 points)
- Skills & Competencies for the assignment (maximum 10 points)
- Prior experience with WWF-Pakistan (maximum 10 points)

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process

11) DOCUMENTATION AND CONFIDENTIALITY

All documents completed based on requirements of the present RFP shall be the property of the WWF-Pakistan, and shall not without the consent of the WWF-Pakistan be used, reproduced or made available to third parties beyond what is necessary in respect of the fulfilment of the Project. All documents issued and information given to the BIDDER shall be treated as confidential.
