#### **Background of Project & Assignment:**

WWF-Pakistan is working on a project to determine women's roles in IWT and combatting IWT, and the drivers influencing their participation, including vulnerable livelihoods or law-enforcement constraints such as limited representation of women in the wildlife ranger workforce. The new evidence base will support the development of a gender-responsive strategy for the Wildlife Departments and improved IWT policies and frameworks. We aim to engage a consultant to conduct research focused on assessing the representation of women in government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries). Additionally, the consultant will evaluate any underlying challenges that might hinder the nature conservation field from being an inclusive profession for individuals of all genders, and identify opportunities for the sector to become more gender-inclusive. The consultant will be responsible for designing a research methodology and conducting a thorough review of existing policies and frameworks to identify current gaps in policy and support mechanisms. Furthermore, the consultant is expected to conduct interviews and facilitate focus group discussions, etc. by ensuring that information-gathering approaches are attuned to gender sensitivity while collaborating with relevant staff and experts to advance the process of formulating a Gender Action Plan (GAP).

#### The objective of the Consultancy:

#### 3) PURPOSE

We seek to engage a consultant to conduct research focused on assessing the representation of women in government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries). Additionally, the consultant will evaluate any underlying challenges that might hinder the nature conservation field from being an inclusive profession for individuals of all genders and identify opportunities for the sector to become more gender-inclusive. The consultant will be responsible for designing a research methodology in consultation with WWF-Pakistan and conducting a thorough review of existing policies and frameworks to identify current Gender gaps in policy and support mechanisms. Furthermore, the consultant is expected to conduct interviews and facilitate focus group discussions with relevant staff and experts aiming to formulate a Gender Action plan for the integration of all genders.

#### **Specific Tasks:**

- In consultation with the WWF team develop a research methodology that aligns with the project's objectives, including the identification of target stakeholders, and data collection methods.
- Conduct an in-depth review of existing policies related to the biodiversity sector (primarily wildlife, forest, and fisheries) and other sectors about human rights, gender equality, and representation.
   Incorporate and institutionalize explicit positions on mainstreaming gender and social inclusion considerations.
- Conduct an analysis of the current support mechanisms available to employees within the
  government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries) with a
  special focus on their effectiveness by using the gender-sensitive Lens in promoting human rights
  gender diversity, inclusion, quality, and equity.
- Conduct a perception survey among both male and female professionals working in wildlife, forest, and fisheries departments to gather insights on their experiences and perspectives regarding gender representation and inclusivity.
- Conduct a comparative analysis to assess gender representation within the government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries) in contrast to other related sectors in Pakistan
- Develop case studies based on comparative analyses to benchmark gender representation and inclusivity in government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries) in selected regional countries.
- Compile gender-segregated dataof the staff in government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries) for subsequent analysis of the gender distribution.
- Collaborate with WWF Pakistan's team to devise action plans and a monitoring system for gender integration across all levels of the IWT project interventions.
- Develop a comprehensive Gender Action Plan (GAP) outlining current Gender gaps, present key recommendations, and suggest actionable points for integration into relevant government policies.
- Prepare a comprehensive report highlighting the existing gaps in gender representation and inclusivity within government sectors dedicated to biodiversity conservation (wildlife, forest, and fisheries)
- Draft a set of actionable recommendations and policy reforms drawing from the findings set of actionable recommendations, aimed at enhancing gender diversity and inclusivity in these sectors for the future.

#### 4) Deliverables

- Research methodology report outlining the approach, tools, and data collection plan, including extensive field data collection strategies.
- Finalized survey questionnaires/data collection tools and discussion guides as needed, for use during consultative sessions and fieldwork.
- All data collected, including key findings from surveys, focus group discussions, extensive field data collection, and interviews with experts.
- Excel sheets and original versions of data collection forms.

- A detailed report and Gender Action Plan (GAP) summarizing policies, gaps and opportunities related to government sectors dedicated to biodiversity conservation (wildlife, forest and fisheries ) on gender representation, human rights, gender equity and inclusivity.
- the report should also include the effectiveness of existing support mechanisms for employees in government sectors dedicated to biodiversity conservation (wildlife, forest and fisheries) focusing on human rights, gender diversity, quality, and equity.
- Identifying and detailing existing gaps in gender representation and inclusivity within biodiversity conservation sectors.
- An analysis of the Pakistani legal framework regarding gender equality and representation
- Report presenting a set of actionable recommendations and proposed policy reforms aimed at enhancing human-rights integration gender diversity and inclusivity in biodiversity conservation sectors.
- Comprehensive report presenting the findings and insights gathered from the perception survey conducted among professionals in wildlife, forest, and fisheries departments.

- The report must also include statistics on gender representation within biodiversity conservation sectors (wildlife, forest, and fisheries) to related sectors in Pakistan, highlighting differences and potential areas for improvement
- Case studies based comparative analysis report benchmarking gender representation and inclusivity in biodiversity conservation sectors across selected regional countries.
- Compile quantitative data on gender representation, incorporating insights gained from the extensive field data collection process.
- Documentation of consultative sessions, including agendas, summaries, and outcomes, as part
  of the comprehensive fieldwork.
- Submit transcripts of interviews with experts, ensuring anonymity and confidentiality, while offering insights into the research findings.
- Provide detailed records and documentation of extensive field data collection efforts, including photographs, notes, and observations made during fieldwork activities.
- All data, tools, and information generated will be the exclusive property of WWF, with the
  consultant prohibited from using or sharing it beyond the assignment's scope. This work serves
  WWF's conservation efforts and remains confidential, with strict copyright and confidentiality
  agreements in place.

#### Qualification

- A background in social sciences, gender studies, law, policy research or a related field, with a minimum of 10 years of experience in conducting policy research and gender-specific research.
- Expertise in designing and implementing research methodologies, particularly in the context of gender gaps assessment and biodiversity conservation.
- Strong data collection and analysis skills, with experience in both quantitative and qualitative research methods.
- Excellent communication and report-writing skills.
- Proven experience in working collaboratively with multidisciplinary teams and engaging with local communities.
- Understanding of the ethical considerations related to research involving vulnerable or at-risk populations and commitment to maintaining data privacy and confidentiality.
- Fluency in English and Urdu, with additional proficiency in local languages preferred.
- Knowledge of the wildlife conservation and illegal wildlife trade context in Pakistan is a plus.

Service Provision Timeline - Provide Detailed Work Plan as per Deliverable and TORs.

**Financial Proposal-** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

#### 8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

**The Payment Term**: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

#### 9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

Technical Proposal (70%)

- Detailed workplan
- Expression of interest (EOI)
- Company's Profile
- Detailed methodology

#### Financial Proposal (30%)

- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
- Company's registration certificate
- NTN detail(s)
- Any legal or technical certification required for the task

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process.
