1) INTRODUCTION & BACKGROUND

Contract type: Consultancy and Services

Duration of assignment: 1st November 2023 – 31st December 2023

Balloki Barrage is a unique wetland habitat that provides refuge to diverse range of riverine and terrestrial wildlife species.(Ashraf et al.,2023)). The wetlands and its ecological profile of water quality, vegetation, and wildlife, offer valuable insights for conservation efforts. The site is also preferred visiting place for many of the people from the surrounding areas. Key species that are found in this area are freshwater turtle, fish, migratory and resident birds, mammals. key threats in this area includes human activities such as pollution, habitat destruction, and overfishing pose a threat to the biodiversity of the area (Pervaiz et al.,2018).

Examination of ecological characteristics of wetlands along the river Ravi, with a specific emphasis on Balloki Barrage, Shows a mix of lively ecosystems. This unique ecosystem is home to a variety of plants and animals, including vibrant flora like water lilies, bulrushes, and various species of submerged aquatic plants. Due to this immense ecological, economic importance the site and the threats it is important to monitor the state and health of ecosystem and associated biodiversity in this ecosystem should be assessed on a regular basis. Furthermore, research of such scope also provides the basis to gather evidence of positive and negative trends in the state of various indicator species that this wetland hosts, the objective of this assignment therefor is to conduct a comparative analysis of the occurrence and trend of selected components of biodiversity to serve as updated baseline for future management and conservation.

3) PURPOSE OF CONSULTANCY

The primary objective of this consultancy is to develop an ecological profile of a selected priority area in and around Balloki Barrage. The specific emphasis of this research will be to conduct a comparative assessment of the status of biodiversity, building on the existing research and knowledge base. The study will also focus on conducting a status assessment survey of selected components of biodiversity, along with evaluating the scale of threats they face. Additionally, the consultancy will cover a stretch of two kilometers both upstream and downstream from the identified site. The assignment would also be working towards developing an eco-tourism promotion plan for this site.

Consultancy Outputs:

- Conduct a comparative review o Develop a comprehensive ecological profile of the selected priority area in and around Balloki Barrage, detailing its biodiversity, habitat characteristics, and ecological dynamics.
- Conduct a comparative assessment of the status of biodiversity for the target areas using existing research, data, and knowledge to analyze trends, patterns, and changes over time.
- Conduct detailed status assessment survey of selected components of biodiversity, including flora, fauna, and ecosystems, to evaluate their current condition, distribution, and health.
- Carry out a threat assessment to assess the type, nature and intensity of the threats faced by the selected components of biodiversity.
- Develop an eco-tourism promotion plan for the site, outlining strategies, recommendations, and initiatives for the Balloki Barrage.

4) DELIVERABLES

The consultant(s) is expected to perform the following tasks and submit the following deliverables as per thetimelines mentioned in clause 5 of this RFP:

- A detailed report presenting the findings from the comparative assessment of the status of biodiversity for the target areas.
- A survey report focusing on selected components of biodiversity, including flora, fauna, and ecosystems. This report will evaluate their current condition, distribution, health, and provide recommendations based on survey findings
- A threat assessment report outlining the results of the threat assessment conducted to assess the type, nature, intensity, and impact of threats faced by the selected components of biodiversity.
- An eco-tourism plan for the Balloki Barrage site outlining strategies, recommendations, initiatives, and actionable steps
 to promote sustainable eco-tourism, conservation efforts, community engagement, and responsible management
 practices.
- Water Quality analysis of surface and groundwater of the area.

- Experience in developing and implementing eco-tourism promotion plans, sustainable tourism initiatives, and community-based conservation projects.

10) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- a) Technical Proposal 70%
- b) Financial Proposal 30%

The following criteria shall be used as a basis for evaluation of technical proposals:

Qualifications (maximum 30 points)

- Experience relevant to the assignment (maximum 30 points)
- Adequacy of the proposed methodology and work plan (maximum 20 points)
- Skills & Competencies for the assignment (maximum 10 points)
- Prior experience with WWF-Pakistan (maximum 10 points)

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
