1) INTRODUCTION & BACKGROUND

Contract type: Consultancy and Services

Background of Project & Assignment:

WWF-Pakistan with the financial support of FCDO, implementing a project titled, "Scaling up nature-based solutions for improving integrated water resources management and enhanced water security in Pakistan". The project aims to pilot Nature-based Solutions (NbS) at selected locations in Gilgit-Baltistan and Khyber Pakhtunkhwa in partnership with relevant stakeholders. Water management for improving the health of natural ecosystems, better water resource management, and livelihood improvement will be outcomes of the project interventions

WWF-Pakistan under the WRAP project aims to promote agricultural water stewardship through the introduction of less water-intensive crops and improved water productivity for fruit orchards via demonstrations and trainings. In this regard, WWF-Pakistan is planning to conduct comprehensive training/demonstrations on on-farm management of crops and techniques to improve water productivity for fruit orchards. These trainings are aimed at introducing sustainable farming practices including irrigation methods and farming behaviors, with a focus on fostering agricultural water stewardship among the farming communities in Gilgit-Baltistan. Moreover, the intervention will help enhance the agricultural productivity in the region.

3) PURPOSE

a. Objective of the Consultancy:

The objectives of the consultancy are to:

- 1. Promote agricultural water stewardship
- 2. Promote sustainable farming practices.

- 3. Enhance on-farm water management
- 4. Assessing the current farming practices including irrigation methods and behaviors

b. Specific Tasks:

The trainer will be responsible for the following points during training:

- 1. Development of comprehensive training modules on the on-farm management of crops encompassing components from seed sowing to harvesting including but not limited to on-farm water management, sustainable weed management, sustainable irrigation techniques, and harvesting methods
- 2. Development of visual material (graphs/charts) covering the relevant facts and figures for the training on the on-farm management of crops
- 3. Imparting training via on-field demonstration
- 4. Development of a comprehensive training/demonstration module on the techniques to establish fruit orchards and improve water productivity for fruit orchards.
- 5. Development of visual material (charts/graphs) for the training and demonstration
- 6. Demonstration of the techniques to establish fruit orchards and improve water productivity for fruit orchards
- 7. Conduct pre and post-training assessments to measure the effectiveness of the training and develop a report

4) Deliverables

The deliverable for the consultancy is to:

- 1. Training material including modules and charts
- 2. Pre and post-training assessment data and report
- 3. Training report

5) REQUIREMENTS

a. Eligibility

The trainer should be eligible to impart comprehensive training on the on-farm management of crops and fruit orchards in the context of Gilgit-Baltistan.

MSc (Hons) Agriculture/horticulture/agronomy/soil science

c. Experience

At least 05 years of relevant experience in crop management and imparting comprehensive training on the on-farm management of crops and fruit orchards in the context of Gilgit-Baltistan. Candidates with experience in trialing the less water-intensive varieties of crops (Wheat-Akbar 2019, Pea-climax, Barley-Basingo, Buckwheat-Mancan) in Gilgit-Baltistan will be preferred.

7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

2) Experience:

- **a) Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) Provide template of already complete similar type of reports- the WWF-PAKISTAN may request additionally;
- 5) Service Provision Timeline Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, 600,000 ONLY, the total price shall include all costs related to service provision including applicable taxes.

8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, 600,000 ONLY, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
 - Detailed workplan
 - Expression of interest (EOI)
 - · Company's Profile
 - Detailed methodology
- B) Financial Proposal (30%)
 - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead

- Company's registration certificate
- NTN detail(s)
- Any legal or technical certification required for the task
- Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
