#### **Background of Project & Assignment:**

WWF-Pakistan with the financial support of FCDO, implementing a project titled, "Scaling up nature-based solutions for improving integrated water resources management and enhanced Water security in Pakistan". The project aims to pilot Nature-based Solutions (NBS) at selected locations in the districts of Khyber Pakhtunkhwa including Abbottabad, Haripur, Mansehra, and Kohistan, similarly in several districts of Gilgit-Baltistan in partnership with relevant stakeholders. Water management for improving the health of natural ecosystems, better water resource management, and livelihood improvement will be outcomes of the project interventions.

#### 2) GENERAL CONDITIONS

## 3) PURPOSE

#### a. Objective of the Consultancy:

This assignment aims to provide training to local farmers on Batter Management Practices in agriculture. In these districts, the major crops are a variety of seasonal vegetables, fruit orchards, wheat, maze, barley, pulses, mustard, sugarcane in the case of Haripur, rice in the case of Mansehra, and kidney bean in the case of Kohistan, while the rest are common in all the districts. The duration of the training will be three days including a field visit to a nearby seasonal crop field.

#### 4) Deliverables

- An introductory meeting will be conducted immediately upon the signing of the agreement to discuss the assignment in detail and lock in the training dates and venue;
- A draft version of the modules/curriculum will be submitted to WWF-Pakistan before the delivery of the training that include but is not limited to the topics of "common challenges for farmers; From where to buy Seed; Seedbed preparation; Laser land for efficient use of irrigation water and high-efficiency irrigation system; Zero tillage practices for sowing in case more moisture available in the soil; Deep tillage to break hard pan and use chisel, mouldboard plough, etc; Seed rate; Seed treatment; Planting time; Various methods of Planting techniques like broadcast sowing, line sowing, ridge sowing, raised-bed sowing; Seed placement; Plant to plant and row to row spacing; Maintenance of plant population per are (unit area) and proper thining; Soil Testing laboratory bases; Soil testing manually; Soil fertility management; Standard doses of Fertilizers, time and application techniques (Split Doses application timing); Time of application and doses of farm yard manure (Compost Manure) to improve soil texture and structure; Manual soil testing; Micro-nutrients requirements and application techniques; Integrated weed management through biological method; Integrated pest management -through biological method; EM technology; Water Quality; How to maximize Water-use efficiency; Irrigation methods & critical timing of moisture availability; Irrigation water saving and Water Harvesting Techniques; Crop Rotation; Intercropping, relay cropping, double cropping for efficient utilization of resources; Inclusion of soil building crops for soil improvement; Beneficial and non-beneficial insect; Crop maturity; Harvesting; Post-harvest losses and management of harvest losses; Post-harvest practices; Storage; Kitchen gardening; Less water intensive crops; Marketing and enhancing the sales of agriculture products; Creation of marketing linkages; Climate-smart agriculture practices; Reasons of low yield; Techniques of climate-smart agriculture practices; Seed production at community level/farmers level; Quality of seeds; How to maintain the quality of Seed by farmers.
- The consultant will be responsible for conducting three days long theoretical and practical training for 25-30 farmers on Best Management Practices for the farmers of districts Mansehra, Kohistan, Haripur, and Abbottabad at any one decided place and provide external training materials, among these, PowerPoint presentations, workshop exercises, tools/resources, and handouts for the training attendees;
- The consultant will also provide technical assistance and support to the farmers to ensure that they can apply the knowledge and skills acquired during the training.
- Develop and deliver a final report on the training.

#### 5) PROJECT/ASSIGNMENT TIMELINES

The duration for this assignment is 50 days that is from 10<sup>th</sup> June to 30<sup>th</sup> July 2024.

# 6) REQUIREMENTS

#### a. Qualification

The applicant/consultant has a professional Master's degree in Agriculture (preferably in Production Science).

#### b. Eligibility

The applicant/consultant should be knowledgeable about every field of production agriculture and have significant knowledge about Integrated Pest Management, all the Agriculture Better Management Practices, Land preparation, biological methods of pest and herb control, etc. The applicant should have better experience in farmer's capacity building programs and have a better understanding of the challenges, variety of crops, and conventional agriculture practices.

#### c. Experience

The applicant/consultant should have a total experience of over 05 years in agriculture training and capacity building.

#### 8) FORMAT OF THE PROPOSAL

The BID/RFP submitted by the participant must be structured as per the below provided instructions:

  - a) Description of the complete projects: the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.

- 4) **Provide template of already complete similar type of reports-** the WWF-PAKISTAN may request additionally;
- 5) **Service Provision Timeline** Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

## 9) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

**The Payment Term**: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

# 10) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
  - Detailed workplan
  - Expression of interest (EOI)
  - Company's Profile
  - Detailed methodology
- B) Financial Proposal (30%)
  - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses.
     The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
  - Company's registration certificate
  - NTN detail(s)
  - Any legal or technical certification required for the task
  - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
