#### **Background of Project & Assignment:**

WWF-Pakistan with the financial support of FCDO, implementing a project titled, "Scaling up nature-based solutions for improving integrated water resources management and enhanced Water security in Pakistan". The project aims to pilot Nature-based Solutions (NBS) at selected locations in the districts of Khyber Pakhtunkhwa including Abbottabad, Haripur, Mansehra, and Kohistan, similarly in several districts of Gilgit-Baltistan in partnership with relevant stakeholders. Water management for improving the health of natural ecosystems, better water resource management, and livelihood improvement will be outcomes of the project interventions.

One of the essential metrics in project Management is Value for Money (VfM), ensuring that resources are utilized to their fullest potential. The VfM framework assesses projects based on principles of economy, efficiency, effectiveness, and equity, providing a systematic approach to evaluating costs and benefits. All FCDO funding projects must ensure the value of money through the VfM framework of assessment.

#### Some of critical considerations for VFM include:

- Data Requirements: The VfM assessment necessitates access to data pertaining to the program's costs, benefits
  or value, and the price of desired outcomes.
- Benchmarking: To facilitate comparisons, the use of appropriate benchmarks is indispensable. Obtaining data
  and information on outcomes may pose challenges, particularly if they are novel and lack comparator
  references.
- Data Analysis Competency: Prospective VfM assessment demands the manipulation of both historical and
  projected data, which necessitates a certain level of data analysis proficiency. In scenarios where data remains
  unquantifiable (e.g., outcomes) or lacks comparability (e.g., 'complex products' with multiple stakeholders and
  goals), qualitative assessments might be required. Nevertheless, a mixed-method approach combining
  qualitative and quantitative methodologies yields more robust results, bridging data gaps, cross-verifying
  findings, and enhancing the credibility of informed judgments.
- Handling Uncertainty: Generating prospective estimates for outcomes and impacts is particularly challenging in situations marked by uncertainty, such as fragile environments prone to unexpected events.

#### 3) PURPOSE

#### a. Objective of the Consultancy:

The objective of this consultancy is the development of a web-based portal/softwear capable of conducting automated VfM assessments, and facilitating objective and consistent project evaluations, as discussed above to support the project in better coordination and implementation.

#### 4) Deliverables

- Develop the program/modules that can automatically assess the value for money of WRAP project in align with the requirements of FCDO.
- Integrating the VfM framework into an automated, web-based assessment tool.
- Data collection from various sources and its automatic integration with the backend of the portal in almost real-time.
- Designing a scalable and secure web application using latest framework
- Incorporating complex functionalities such as multi-criteria decision analysis (MCDA), risk assessment modules, and scenario simulation capabilities.
- Work closely with the Senior Manager Economist ,Project Opeartion Team and other relevant partners to ensure
  consistency of data collection, compile and archive analyses and reporting of various primary and secondary data from
  various sources.
- Training to be conducted for the capacity building of users of the dashboard.
- Prepare the MIS operational manual to be friendly user
- Maintenance support during the first year

#### 5) PROJECT/ASSIGNMENT TIMELINES

The duration for this assignment is 99 days, from 24 June to 30th September 2024.

#### 6) REQUIREMENTS

- **a) Technical Specifications** The web portal should be developed using Java, .NET, Python, SQL VS Code or VB.NET, with a backend database like PostgreSQL, MySQL, or SQL Server, and SAP Crystal Reports for report creation to ensure high performance and optimization. The following conditions apply:
- The application must support server-side rendering and static generation for optimal performance.
- The application should be optimized for search engines.
- The portal should be compatible with modern web browsers and responsive to different screen sizes.
- Advanced data visualization tools like Recharts or Power BI must be integrated to represent assessment results effectively.
- b) Complex Requirements The portal must meet the following complex requirements:
- The VFM software has capabilities in the future to be used in WWF national offices/projects, with necessary modifications made to the module depending on the objectives of each office/project.
- A robust user authentication and authorization system ensuring data security.
- An interactive dashboard with real-time data analytics and reporting features.
- Automated data import/export capabilities with support for various file formats.
- Customizable assessment criteria and weightings to adapt to different project types.
- Conceptual VFM skills and analysis will be advantages of Firms/individual

- Successfully implement the VFM modules and connecting all modules;
- The details of each module are (Summary, introduction, Data Checklist, Quantitative Calculator, Qualitative Assessment, Economy Calculation, Cost & benefit Summary, Supplementary Calculation, Cost of Intervention Summary, Program Cost Calculation, Cost Benefit Analysis, Flood Damage Cost, Flood Damage Factor, Assume Benefit and Economic data etc)

#### 9) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

#### 10) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
  - Detailed workplan
  - Expression of interest (EOI)
  - Company's Profile
  - Detailed methodology
- B) Financial Proposal (30%)
  - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses.
     The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
  - Company's registration certificate
  - NTN detail(s)
  - · Any legal or technical certification required for the task
  - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
