Any additional information required for preparation of the BID shall be distributed to all participants at the same time.
- 3) The WWF-PAKISTAN reserves the right to award the proposal based on experience, qualification, completion date, service cost and other criteria, and not necessarily the lowest cost.
- 4) Based on the RFP BID the WWF-PAKISTAN is entitled to change/replace or omit any clause/part of the preliminary defined scope of services of the proposal. The WWF-PAKISTAN shall conduct negotiations with WWF to achieve the full compliance to the requirements.
- 5) The WWF-PAKISTAN reserves the right in the event the successful CONSULTANT fails to comply with the terms and conditions as listed, to cancel this contract and award it to another CONSULTANT without penalty or action against the WWF-PAKISTAN. The RFP does not constitute an agreement or order.

#### 3) PURPOSE

#### a. Objective of the Consultancy:

- 1. Capture high-quality photographs and create a compelling video documentary that showcases the project's achievements and impacts.
- Document the beach cleanup, the installation of the Plastic Recovery Bank, awareness sessions and training programs at universities.

#### b. Specific Tasks:

- 1. Plan and organize filming schedules, locations, and manage logistics for on-site filming of project activities and interventions
- 2. Utilize creative storytelling techniques and visual elements, utilize a 4k camera with a focused array of shots.
- 3. Ensure accuracy, objectivity, and adherence to ethical standards in presenting information and representing stakeholders' perspectives.
- 4. Incorporate feedback and make necessary revisions to align with the project's objectives and expectations.
- 5. Deliver a high-quality, professional photography and video documentary in accordance with the agreed-upon timelines and specifications.
- 6. Submit background music for review and approval by the WWF Communications Team prior to use.

#### 4) Deliverables

- 1. A concise and impactful short video of five minutes that encapsulates the essence of the project.
- 2. A short snippet video, two to three minutes in length, that can be used independently as a standalone product. Subtitles should be incorporated for wider accessibility.
- 3. High-quality, original photographs of key moments, activities, and beneficiaries of the project. These images will serve as a visual narrative, complementing both the documentary and the short video.

#### 5) Requirements

- Four years or more experience in producing development work related documentaries for organizations, International NGOs, development sector or donor agencies with the aim of reaching out to both local and international audiences
- 2. Strong technical capacity (state of art filming equipment) to ensure smooth and high-quality production of the documentary.

#### 7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

- a) Description of the complete projects: the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) Provide template of already complete similar type of reports- the WWF-PAKISTAN may request additionally;
- 5) Service Provision Timeline Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

#### 8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

#### 9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
  - Detailed workplan
  - Expression of interest (EOI)
  - Company's Profile
  - Detailed methodology
- B) Financial Proposal (30%)
  - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
  - Company's registration certificate
  - NTN detail(s)
  - Any legal or technical certification required for the task
  - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process

#### 10) DOCUMENTATION AND CONFIDENTIALITY

All documents completed based on requirements of the present RFP shall be the property of the WWF-Pakistan, and shall not without the consent of the WWF-Pakistan be used, reproduced or made available to third parties beyond what is necessary in respect of the fulfilment of the Project.
