The WWF-PAKISTAN has no obligation to notify the other BIDDERS of the discussions, clarifications, or other information provided by a BIDDER. Any additional information required for preparation of the BID shall be distributed to all participants at the same time.
- 3) The WWF-PAKISTAN reserves the right to award the proposal based on experience, qualification, completion date, service cost and other criteria, and not necessarily the lowest cost.

## 3) PURPOSE

### a. Objective of the Consultancy:

WWF-Pakistan with the financial support of the Foreign, Commonwealth & Development Office (FCDO), implementing a project titled scaling up nature-based solutions (NbS) for integrated water resource management and enhanced water security in Pakistan. The project aims to pilot nature-based solutions (NbS) in selected sites of Gilgit Baltistan and Khyber Pakhtunkhwa in partnership with relevant stakeholders. The project outcomes include water management for improved health of natural ecosystems, better water resource management, and livelihood improvement. The project was started in November 2021 and will be ending in March 2026.

### The main objectives of this assignment are as follows:

- Develop climate adaptation plans for five districts out of the ten, within Gilgit-Baltistan namely Gilgit, Astore, Nagar, Kharmang & Ghanche.
- Develop climate change adaptation plans for the five districts of Gilgit Baltistan and incorporate Nature-based solutions into the plans.

- Integrate nature-based solutions into climate change adaptation plans to enhance ecosystem resilience, mitigate climate risks, and promote sustainable development.
- Foster stakeholder engagement and ensure the plans are inclusive, incorporating local knowledge and community participation.

**b. Specific Tasks:**

- 1) Develop and share a detailed work plan (with timeline, responsibilities, and deliverables) for developing a climate change adaptation plan and seek feedback from WWF-Pakistan.
- 2) Prepare an outline for the climate change adaptation plan and share it with WWF-Pakistan. Develop and share questionnaires for taking feedback from communities including female representatives, relevant stakeholders and legislative body for the CCAPs.
- 3) Review the guidelines for creating a climate change adaptation plan provided by the National Disaster Management Authority (NDMA), Government of Pakistan.
- 4) Review of the secondary data including but not limited to:
  - i. Review the existing GB DRMP revised in 2022 for literature review and its incorporation in the climate change adaptation plans.
  - ii. Review of relevant policies and strategies of the provincial and national governments which shall guide the climate change adaptation plan development process.
  - iii. Review the “Gilgit-Baltistan Climate Change strategy and Action Plan” and Gilgit-Baltistan Climate Change Adaptation Action plan”
- 5) Consult the Sendai framework of Action (2015-2030) and other relevant globally recognized best practices and frameworks to integrate the learnings in the climate change adaptation plans.
- 6) Conduct a comprehensive assessment of the climate change vulnerabilities and risks in the five selected districts of Gilgit-Baltistan.
- 7) Identify and prioritize nature-based solutions that are suitable for each district, considering their ecological, socio-economic, and cultural contexts.
- 8) Prepare climate change adaptation plans based on the NbS Framework developed by WWF-Pakistan.
- 9) Develop district-level climate adaptation plans, including specific goals, objectives, strategies, and actions for each district, aligned with national and provincial policies and frameworks.
- 10) Ensure the integration of nature-based solutions into the adaptation plans, focusing on ecosystem-based approaches such as reforestation, watershed management, ecosystem restoration, and green infrastructure.
- 11) Conduct stakeholder consultations and engagement workshops at the district and provincial levels to gather input, validate findings, and ensure local ownership of the plans.
- 12) Assess the impact of the tourism flow on the fragile mountain ecosystem and its impacts on the available natural resources and mountain communities.
- 13) Meeting with the relevant department to collect data for site-specific climate change adaptation plans.
- 14) Developed climate change adaptation plan building upon the National Adaptation Plan 2023.
- 15) Developing adaptation strategies and measures to mitigate climate change risks.
- 16) WWF-Pakistan has already developed adaptation plans for five districts in Gilgit-Baltistan (GB). The consultant will also revise these existing plans as per feedback received from the line department so that all ten districts will have uniform formats and adaptation plans.
- 17) Develop the GIS-based hazard and vulnerability risk assessment maps for the relevant district.
- 18) Collect primary data with the consultation of the local communities to use their indigenous knowledge where appropriate to ensure ownership of the local communities.

#### 4) Deliverables

1. Climate vulnerability assessment reports for each district, highlighting key risks, vulnerabilities, and priority areas for intervention.
2. Nature-based solutions assessment report for each district, identifying suitable interventions and their potential benefits.
3. District-level climate change adaptation plans, including goals, objectives, strategies, and actions, integrating nature-based solutions.
4. District-level climate change adaptation plans, and if it already exists then incorporate Nature-based solutions into the existing plan.
5. Stakeholder engagement reports, documenting the consultation process, key recommendations, and feedback received.

6. Arrange the stakeholder consultation session for the launching of the climate change adaptation plan.
7. The consultant will also review/ revise existing Climate Change Adaptation plans as per feedback received from the line department so that all ten districts will have uniform formats and adaptation plans.

## 5) REQUIREMENTS

The candidates/firm should have the following set of competencies and qualifications for this consultancy assignment.

- At least a Master's degree in Environmental Science/Engineering, Development Economics, climate change, sustainable development, or other related fields from a recognized university, with a solid understanding of climate projections and vulnerability assessments.
- Minimum 5 years of experience developing climate change adaptation strategies and plans.
- Experience in working with international donors especially FCDO would be an advantage.
- Sound knowledge and understanding of Nature-based Solution concepts, and approaches used in the development sector, emphasizing water and climate.
- Proven English language proficiency, quality report writing, analytical and presentation skills.
- Experience with addressing gender and social inclusion issues in the project development and implementation plans
- Experience in doing vulnerability assessments for conservation and nature-based solutions would be an advantage.
- Experience in designing and/or coordinating for reporting on climatic, environmental, social, and economic variables/indicators and a high capacity for inter-institutional coordination is desirable.
- Preference will be given to the firms having knowledge and experience in the context of Gilgit-Baltistan.

## 7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

### 2) Experience:

- a) **Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.

- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) **Provide template of already complete similar type of reports-** the WWF-PAKISTAN may request additionally;
- 5) **Service Provision Timeline** – Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal-** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

## 8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

**The Payment Term:** shall be defined by the contract agreement to be concluded between WWF -Pakistan and the consultant/firm.

## 9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

A) Technical Proposal (70%)

- Detailed workplan
- Expression of interest (EOI)
- Company's Profile including prior experience of developing adaptation plans
- Detailed methodology
- CVs/Experience of relevant personnel who will be responsible for developing the plans on the ground.

B) Financial Proposal (30%)

- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
- Company's registration certificate
- NTN detail(s)- Individuals/firms from GB will not be require however Individuals/Firms outside GB will have to submit NTN
- Any legal or technical certification required for the task
- Audited Accounts Report (if available) of last FY for firms, Association of Person, Single Member Company,

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
