Background of Project & Assignment:

WWF-Pakistan's Sustainable Infrastructure initiative (SII) has been leading and supporting WWF International's Sustainable Infrastructure ACAI (SI ACAI) in its knowledge management and policy work since 2020. Moreover, Pakistan's SII also uses the learnings and findings from our national work to support and inform the Network's linear infrastructure (roads, railways, power lines etc.) strategy.

WWF-Pakistan also now seeks to work towards developing a link between the SI ACAI's work and its contribution towards the realization and contribution to Target 14 of the Global Biodiversity Framework (GBF) of the Convention on Biological Diversity (CBD). In addition, the aim is to draw best practices and learnings from both our global, regional, and national level SI work and present them as replicable recommendations before COP16 and future negotiations at the upcoming UNFCCC and CBD COPs.

As a first step, the WWF team shall be presenting their work and push for commitments pertaining to infrastructure at the upcoming COP16. As a way to capture discussions, negotiations and outcomes at COP16 and present them in the form of a report that analyzes our approach and provides recommendations, WWF seeks the services of a technical writer who has up to 8 years of experience in report writing, policy review, and research to develop a report on the aforementioned.

2) GENERAL CONDITIONS

2. Use information shared to develop a report or brief summarizing the discussions, negotiations and outcomes at COP16 related to infrastructure, and provide analysis and recommendations.

7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

- 1) **Application Form available at WWF-Website** - General information about the Bidder, covering qualification and experience, CV and all related Information.
- 2) **Experience:**
 - a) **Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) **Provide template of already complete similar type of reports-** the WWF-PAKISTAN may request additionally;
- 5) **Service Provision Timeline** – Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal-** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct

and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any). The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of KP

The Payment Term: shall be defined by the contract to be concluded between WWF -Pakistan and the consultant.

9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
- Detailed workplan
 - Expression of interest (EOI)
 - Company's Profile
 - Detailed methodology
- B) Financial Proposal (30%)
- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
 - Company's registration certificate
 - NTN detail(s)
 - Any legal or technical certification required for the task
 - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process

10) DOCUMENTATION AND CONFIDENTIALITY

All documents completed based on requirements of the present RFP shall be the property of the WWF-Pakistan, and shall not without the consent of the WWF-Pakistan be used, reproduced or made available to third parties beyond what is necessary in respect of the fulfilment of the Project.
