Background of Project & Assignment:

Taunsa Conservation and Information Centre located at the Taunsa Barrage, Punjab is a pivotal hub for preserving aquatic and riverine biodiversity along the Indus River. Established nearly two decades ago, its mission revolves around raising awareness about the significance of the Indus River Dolphin and promoting the

conservation of crucial resources. The Centre plays a pivotal role in educating local communities and citizens about the importance of safeguarding wildlife and the Indus River. For many years the place

3) PURPOSE

a. The objective of the Consultancy:

The main goal of the exposure visit is to raise awareness about the unique and valuable biodiversity of the Indus River. The focus will be on the Indus River Dolphin and other river ecosystems, highlighting the challenges they face. Through engaging experiences and educational activities, participants will gain a better understanding of the crucial role played by the Centre in conserving these natural resources. The visit provides a special chance to explore the Taunsa Barrage Wildlife Sanctuary, which is home to the endangered Hod Deer and the Indus River Dolphin. Participants will enjoy a view of the Indus River, interact with local communities, and experience the peaceful environment of our modern Taunsa Conservation and Information Centre.

b. Specific Tasks:

The consultancy firm/company or individual is expected to undertake the following tasks

- Provide a Guided tour to observe the endangered Indus River Dolphin and Hod Deer in their natural habitat.
- Deliver a lecture on the Indus River's biodiversity and the conservation challenges it faces through expert-led presentations.
- Engage communities in hands-on activities highlighting key efforts to protect riverine ecosystems and species.
- Interact with local communities to understand their role in ecosystem preservation and sustainable resource use.
- Enjoy a guided scenic view of the Indus River while learning about its unique environmental features.
- Explore exhibits detailing conservation initiatives and gain resources on current and future projects.

4) Deliverables

The consultancy is expected to deliver the following:

- Document observations of key species like the Indus River Dolphin and Hod Deer at Taunsa Barrage Wildlife Sanctuary.
- Summarize key insights from educational sessions on the Indus River ecosystem's challenges and conservation strategies.
- Provide a list of action items from the conservation workshop, highlighting practical techniques learned.

- Write a reflection on community interactions, focusing on sustainable practices and local conservation roles.
- Note key ecological features and environmental indicators observed along the Indus River.
- Summarize impactful exhibits and resources from the Taunsa Conservation and Information Centre, including ideas for follow-up activities. All data, tools, and information generated will be the exclusive property of WWF-Pakistan, with the consultant prohibited from using or sharing it beyond the assignment's scope. This work serves WWF's conservation efforts and remains confidential, with strict copyright and confidentiality agreements in place.

5) REQUIREMENTS

a. Qualification

- At least a master's degree in relevant fields
- Well-reputed firm capable of undertaking the desired assignment as described in the Scope of work and at least 5–10 years of experience in the work the development sector with a proven track record of developing and implementing similar tasks
- Specific knowledge or experience related to the Indus River ecosystem and its biodiversity, especially the Indus River Dolphin, with a focus on translating this knowledge into effective design elements.
- Prior experience working with WWF will be an advantage.

7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

1) **Application Form available at WWF-Website -** General information about the Bidder, covering, qualification and experience, CV and all related Information.

2) Experience:

- a) **Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, and conditions;
- 4) **Provide template of already complete similar type of reports-** the WWF-PAKISTAN may request additionally;
- 5) **Service Provision Timeline** Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal-** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant / Firm / Company will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of Punjab.

The Payment Term: shall be defined by the contract to be done between WWF-Pakistan and the consultant / Firm / Company.

9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

A) Technical Proposal (70%)

- Detailed workplan
- Expression of interest (EOI)
- Company's Profile
- Detailed methodology

B) Financial Proposal (30%)

- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
- Company's registration certificate
- NTN detail(s)
- Any legal or technical certification required for the task
- Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process

10) DOCUMENTATION AND CONFIDENTIALITY
