Background of Project & Assignment:

WWF-Pakistan with the financial support of NIKE, implementing a project titled, "Integrated Water Resources management in Indus Basin". The project aims to pilot Nature-based Solutions (NBS) at selected locations in South Punjab, Soon valley & Uchali Complex and nathia galli in partnership with relevant stakeholders. Water management for improving the health of natural ecosystems, better water resource management and livelihood improvement will be outcomes of the project interventions.

2) GENERAL CONDITIONS

- 1) The WWF-PAKISTAN reserves the right to reject or accept any proposal. The WWF-PAKISTAN reserves the right to proceed with the implementation of any Service, in whole or in part, as described in the Proposal.

3) PURPOSE

a. Objective of the Consultancy:

- To conducts a comprehensive impact assessment of water management interventions in South Punjab, focusing on evaluating their replenishment capacity, societal and environmental impact
- To identifying areas for improvement to enhance sustainability and efficiency in installed interventions and water resource management.

b. Scope of the Consultancy:

- 1. Conduct detailed site visits to assess the functionality and effectiveness of the installed water management interventions, including Ablution Water Reuse Systems, Recharge wells, Floating Treatment wetland, Rainwater harvesting systems, Water Course lining and Laser land levelling.
- 2. Evaluate the replenishment capacity of each intervention and its impact on water availability for agricultural and community use.
- 3. Analyze the societal benefits, including community engagement, livelihood improvement, and socio-economic impacts of the interventions.
- 4. Assess the environmental impact, such as the enhancement of local ecosystems, reduction of water wastage, and improvement in water quality.
- 5. Identify gaps or areas where the interventions can be optimized to improve their efficiency and sustainability.
- 6. Develop actionable recommendations to address identified gaps, ensuring long-term functionality and benefits of the interventions.
- 7. Prepare a comprehensive report summarizing findings, conclusions, and recommendations, and present the outcomes to relevant stakeholders.
- 8. Review the previously designed reports and third-party audit reports, and provide us with a comprehensive report based on the given data.
- 9. Review the Volume Water Benefit Accounting (VWBA) methodology and verify the replenishment number on-site using this method.

4) Deliverables

The consultant is expected to deliver the following:

- 1. **Impact Assessment Report:** A comprehensive report detailing the replenishment capacity, societal and environmental impacts, and areas for improvement for all installed interventions.
- 2. **Site-Specific Analysis:** Detailed evaluations of the including Ablution Water Reuse Systems, Recharge wells, Floating Treatment wetland, Rainwater harvesting systems, Water Course lining and Laser land levelling, including individual performance metrics.
- 3. **Recommendations Report:** A document outlining actionable suggestions for optimizing the sustainability and efficiency of the interventions.
- 4. **Community Feedback Summary:** A summary of the feedback collected from local communities regarding the interventions' impacts on their livelihoods and water resource management practices.
- 5. **Presentation of Findings:** A formal presentation of the key findings and recommendations to relevant stakeholders, including local authorities and project sponsors.
- 6. **Letter of Satisfaction:** A letter of satisfaction shared on the consultant's university webpage, confirming the successful completion of the consultancy and its outcomes.

5) REQUIREMENTS

a. Qualification

- A Doctorate degree in Agricultural Sciences or engineering, Water Resource Management, or a related field.
- Proven expertise in implementing water-efficient systems and techniques such as water curse lining, rainwater harvesting, and soil conservation.
- Strong communication and facilitation skills, with experience in engaging rural communities.
- Familiarity with the socio-economic and environmental conditions of the South Punjab region.
- Fluency in Urdu and Punjabi (preferred), with a good command of English.

b. Experience

- At least 5 years of experience in agricultural training and extension, focusing on water management and productivity.
- Experience in working with international or national firms especially WWF-Pakistan would be an advantage.

7) FORMAT OF THE PROPOSAL

The BID submitted by the participant must be structured as per the below provided instructions:

- 2) Experience:
 - **a) Description of the complete projects:** the list and general information about the complete projects, description of the role in the project, other accomplishments of the Consultant.
- 3) **Proposal outlining scope consultancy service-** Description of scope and working process, stages, deliverables, exclusions, conditions;
- 4) Provide template of already complete similar type of reports- the WWF-PAKISTAN may request additionally;
- 5) Service Provision Timeline Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

8) FINANCIAL PROPOSAL

The proposed prices shall be provided in PKR, the total price shall include all costs related to service provision including all Direct and Indirect taxes, Travel, Boarding & Lodging shall be based on actual receipt up to max Ceiling (If Any).

The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan and the Government of Punjab.

The Payment Term: shall be defined by the contract to be concluded between WWF - Pakistan and the consultant.

9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

- A) Technical Proposal (70%)
 - Detailed workplan
 - Expression of interest (EOI)
 - Company's Profile
 - Detailed methodology
- B) Financial Proposal (30%)
 - Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
 - Company's registration certificate
 - NTN detail(s)
 - Any legal or technical certification required for the task
 - Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
