1) INTRODUCTION & BACKGROUND

WWF-Pakistan is leading the project “Combating Wildlife Trafficking in Pakistan” to strengthen the frontline efforts against wildlife crimes. The initiative focuses on building the capacity of rangers to detect, respond to, and investigate wildlife trafficking incidents, while also equipping the judiciary to prioritize wildlife crimes and ensure effective prosecutions. A key component of the project involves improving coordination between provinces and enforcement agencies to close the gaps often exploited by traffickers.

The on-site component of the project is focused on Deva Vatala National Park (DVNP) in Azad Jammu & Kashmir (AJ&K), aiming to address poaching and illegal wildlife trade through the implementation of a zero-poaching framework. This includes the capacity building of rangers and the provision of essential equipment and technology-based tools such as the SMART (Spatial Monitoring and Reporting Tool) system.

To support this effort, we seek to engage a consultant (individual, firm, or organization) to develop customized SMART-based patrolling and illegal wildlife trade (IWT) monitoring and reporting modules for selected staff of the wildlife department. The consultant will also be responsible for building staff capacity in data collection and analysis to support improved planning and targeted response to IWT in Deva Vatala National Park. The consultant is expected to work closely with the project team and the Wildlife and Fisheries Department of AJ&K to conduct a situation analysis including a threat assessment and review existing patrolling practices and data collection tools, leading to the development of site-specific SMART package and training modules.

Spatial Monitoring and Reporting Tool (SMART) is an innovative platform designed to help protected areas and wildlife authorities effectively manage and monitor conservation activities, including efforts to combat illegal wildlife trade. It consists of desktop software and a mobile app intended for use by field staff, researchers, and community stakeholders, enabling efficient data collection, analysis, and reporting. SMART supports a wide range of functions such as biodiversity monitoring, law enforcement, visitor management, and threat assessments ensuring that critical field data reaches decision-makers. In Pakistan, WWF has been training wildlife department staff in two protected areas on the use of SMART to enhance conservation outcomes and address threats such as poaching and illegal trade.

2) GENERAL CONDITIONS

- 1) The WWF-PAKISTAN reserves the right to reject or accept any proposal. The WWF-PAKISTAN reserves the right to proceed with the implementation of any Service, in whole or in part, as described in the Proposal.

7) By submitting a bid, the BIDDER is deemed to have acknowledged all of the undertakings, specifications, terms and conditions, **WWF Fraud and Corruption Prevention and Investigation Policy and WWF's Environment Social & Safeguard for consultant agreement** and to be bound by them if the BID is accepted. All expenses incurred by the Bidder in connection with the preparation of its proposal are to be borne by the RFP participant, and the WWF-PAKISTAN shall not incur any obligation whatsoever toward the Bidder regardless of whether such bid is accepted or rejected.

3) PURPOSE

a. Objective of the Consultancy:

The objective of this consultancy is to;

- i. Undertake a comprehensive threat assessment at Deva Vatala National Park (AJK) with rangers and communities to understand the needs for effective on-site SMART implementation
- ii. Develop customized site-specific SMART packages and modules in collaboration with the SMART Partnership's Capacity Council
- iii. Delivery of one capacity-building workshop (05 to 07 days) for the staff of Deva Vatala National Park and Wildlife and Fisheries Department of AJ&K using the developed SMART package for its integration into the data collection and monitoring system

b. Specific Tasks:

1. Coordinate closely with WWF-Pakistan to finalize the field assessment plan, data collection methodology, and SMART module development process.
2. Develop and share templates for threat assessment, capacity analysis, and resource availability, to be used with rangers, local communities, and wildlife department staff at Deva Vatala National Park.
3. Design a customized SMART package for the site (DVNP), including data models, patrol forms, and reporting templates, tailored to the park's specific conservation needs and operational context.
4. Ensure the package is fully aligned with SMART Global Standards and relevant competence frameworks.
5. Create a structured SMART training module in English for rangers and wildlife officers, covering patrol planning, data collection, analysis, reporting, and the use of both SMART Mobile and SMART Desktop.
6. Delivery of one capacity-building workshop (05 to 07 days) for the staff of Deva Vatala National Park and Wildlife and Fisheries Department of AJ&K using the developed SMART package for its integration into the data collection and monitoring system.
7. Conduct pre- and post-training assessments to evaluate knowledge uptake and the effectiveness of the training.
8. Submit finalized training materials, SMART configuration files, and a brief summary of feedback received from participants.
9. Prepare a concise final report outlining the methodology, assessment findings, training outcomes, and recommendations for scaling or sustaining SMART implementation.

4) DELIVERABLES

1. A site-specific threat and Capacity Assessment Report serving as guidance for designing SMART package
2. Customized SMART Data models/ data collection packages

3. SMART training material including guidance on data models, patrol planning, data collection, analysis, and reporting.
4. Comprehensive Training manual (SMART 7)
5. Submission of a fully configured SMART package (data model, and forms) tailored to the site and ready for use.
6. Delivery of one capacity-building workshop (05 to 07 days) for the staff of Deva Vatala National Park and Wildlife and Fisheries Department of AJ&K using the developed SMART package for its integration into the data collection and monitoring system.
7. A concise final report outlining the methodology, assessment findings, training outcomes, and recommendations for scaling or sustaining SMART implementation.

5) PROJECT/ ASSIGNMENT TIMELINE

The consultant will be responsible to complete all deliverables with the given timeframe of “1st January 2026 to 30th May 2026” – i.e. 5 Months

6) REQUIREMENTS

The consultant will be responsible for developing customized SMART training modules and delivering capacity-building training aligned with SMART Global Standards for implementation in Deva Vatala National Park, AJ&K. The consultant should be affiliated with, or recognized by, the SMART Partnership and possess strong practical experience in implementing SMART for wildlife crime monitoring.

The consultant(s) must meet the following criteria:

- i. At least five (5) years of demonstrated experience in designing, implementing, and training rangers using SMART-based monitoring systems at the national, regional, or global level, preferably within protected areas or national parks.
- ii. Active affiliation with the Global SMART Partnership, including involvement with the Capacity Building Council or contribution to SMART tool development and global standardization efforts.
- iii. Strong expertise in developing customized SMART data models, training modules, and ranger training materials tailored for protected area staff and law enforcement personnel.
- iv. Proven experience in conducting threat assessments and SMART-specific capacity needs assessments.
- v. Familiarity with WWF’s approach to using SMART as part of broader wildlife crime prevention and anti-poaching effort is highly desirable.
- vi. Prior experience in training rangers or protected area staff on SMART use in Pakistan is essential, along with an understanding of local governance structures, enforcement challenges, and institutional frameworks.
- vii. Demonstrated ability to develop technical SMART content into user-friendly training materials and adapt content to the local context of Pakistani wildlife departments.

8) FINANCIAL PROPOSAL

1. The proposed prices shall be provided in PKR for national consultants and USD for international consultants, the prices shall be provided in Pak Rs and USD, the total price must be exclusive of all types of applicable taxes.
2. The consultant will submit the cost of the assignment in a lump sum, including all applicable taxes according to the Government of Pakistan
3. The boarding and lodging (Air and local travel, accommodation and food of one person) will be covered by WWF-Pakistan

9) EVALUATION PROCESS

Applicant's proposal shall be evaluated based on Quality and Cost Based Selection (QCBS) method. Under QCBS both technical and financial proposals shall be evaluated as per following criteria against a maximum score of 100 points.

A) Technical Proposal (70%)

- Detailed workplan
- Expression of interest (EOI)
- Company's Profile
- Detailed methodology

B) Financial Proposal (30%)

- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
- Company's registration certificate
- NTN detail(s)
- Any legal or technical certification required for the task
- Audited Accounts Report (if available) of last FY

Note: Late/ incomplete submissions will not be accepted. Only three (03) top-ranked firms will be included in the comparative process
