1) INTRODUCTION & BACKGROUND

Background of Project & Assignment:

- i. WWF-Pakistan has been awarded a project preparation grant (PPG) by the Global Biodiversity Framework Fund (GBFF) housed under the GEF for its concept note titled “Accessing the Benefits of Biodiversity for Pakistan’s IPLCs: Working Towards the National Legislation and Implementation of the Nagoya Protocol”.
- ii. Currently being implemented in partnership with the Ministry of Climate Change & Environmental Coordination (MOCC&EC), the project will in essence seek to lay the foundation for the ratification and legislation of the Nagoya Protocol through the passage of an Access & Benefit Sharing law, followed up by the establishment of the necessary institutional set ups.
- iii. More importantly, however, this project shall ensure that the benefits – both monetary and non-monetary - derived from the utilization of genetic resources (GR) and Traditional Knowledge (TK) by “users”, i.e. the private sector, are shared fairly with the “providers” of such genetic resources, i.e. Pakistan’s Indigenous Peoples and Local Communities (IPLCs).
- iv. WWF-Pakistan is also looking to develop interactive, engaging, and user-friendly communication products – including fact sheets - which will help provide easy to understand information about the project and the Nagoya protocol to the stakeholders this project shall engage for effective implementation of its outcomes. WWF-Pakistan would also like to develop the overall theme of the project, which includes a logo for the project. To this end, WWF-Pakistan is looking to onboard a consultant who has graphic designer and illustration expertise to assist with the same.

2) GENERAL CONDITIONS

- 1) The WWF-PAKISTAN reserves the right to reject or accept any proposal. The WWF-PAKISTAN reserves the right to proceed with the implementation of any Service, in whole or in part, as described in the Proposal.

- 5) **Service Provision Timeline** – Provide Detailed Work Plan as per Deliverable and TORs.
- 6) **Financial Proposal-** the prices shall be provided in Pak Rs, the total price shall include all costs related to service provision including applicable taxes.

A) Technical Proposal (70%)

- Detailed workplan
- Expression of interest (EOI)
- Company's Profile
- Detailed methodology

B) Financial Proposal (30%)

- Detailed financial proposal which should be inclusive of all applicable taxes and out of pocket expenses. The financial proposal should follow a breakdown structure i.e., specifying cost(s) to each head and subhead
- Company's registration certificate
- NTN detail(s)
- Any legal or technical certification required for the task
- Audited Accounts Report (if available) of last FY
